Sharing Equipment: Competitors needing to share equipment should make it known at time of entry.

Awards: Awards for the winners of the EIC Match will come from CMP.

Scoring & Target Service: Competitors will score and pull targets. Any competitor who does not fulfill his or her scoring or target pulling duties may be disqualified.

Rules: This is an EIC Rifle match and CMP rules will apply. It is the competitor's responsibility to be familiar with the current rules and appropriate equipment requirements. Empty chamber indicators are required

Course of Fire, 50 Shot National Match Course:

Squading: 0630-0800. Safety Brief: 0800. Commence fire: 0830.

- 10 shots slow fire from the standing position at 200 yards in a time limit of 10 minutes.
- 10 shots rapid fire from the sitting or kneeling position at 200 yards in a time limit of 60 seconds.
- 10 shots rapid fire from the prone position at 300 yards in a time limit of 70 seconds.
- 20 shots slow fire from the prone position at 600 yards in a time limit of 20 minutes.

Note: No sighting shots, competitors will stand before each rapid fire stage. Both the standing and sitting stages will be completed before the competitor leaves the 200 yard firing line.
